At present, the 15th Lok Sabha has 58 ladies MPs-- this is the very first time their depiction has gone across 10%. Just 26 ladies Member of Parliament in Rajya Sabha as on 10th October, 2019. The Representation of females in Lok Sabha and Rajya Sabha is very low.

Domestic violence against women is now a big threat to the gender equal rights in India. It has thought an alarming proportion. Besides, the Indian chastening code additionally penalizes the bride-to-be burning, ruthlessness and torture to new brides. The

Indian Evidence Act also gives that accused needs to bear the burden of evidence. Even with regulations, this awful system is still dominating in our country.

Every day, the newspapers publish scary information concerning bride-to-be burning, bride-to-be's self-destruction, bride's murder etc. which is a wonderful shame for our society.

Our Government is additionally devoted to supply protection to ladies versus domestic physical violence by establishing Domestic Violence Act, 2005, which entered pressure on 26th October, 2006 to offer more effective protection of the rights of females guaranteed under the constitution. Any kind of lady that is or has remained in a residential or family relationship if is subjected to any act of domestic physical violence, can complain under the act to the protection police officer and also the appeal can be made to session's court within one month from the order of concerned Magistrate. The Protection of Women from Domestic violence Act (PWDVA) is also carried out by the states/ Union Territories. The state Governments are required to select defense officers, Register Company and alert sanctuary homes as well as clinical facilities for implementation of the Act. The PWDVA is a civil Law implied to protect as well as supply support to sufferers of residential physical violence. Under the Act, the aggrieved woman can seek various alleviations, such as, defense order, residence order, wardship order, settlement order, financial alleviations, shelter and also medical facilities. The Act additionally has a stipulation for appeal versus the orders of the Magistrate.

Likewise, the Union Cabinet approved the intro of the protection of ladies against sexual Harassment at workplace Bill, 2010, in the parliament to make certain a secure environment for women at the workplace places, both in public as well as economic sectors whether arranged or messy. The Expense supply defense not only to women who are utilized, yet also to any type of female that enters the office as a customer, consumer, pupil and also daily wage employee or in ad-hoc capacity. The action, therefore, will help in achieving sex empowerment as well as equality in India. Despite of these legislative measures embraced by the Federal Government of India along with state Federal Governments in favor of women, numerous females of the country

still remain to be victims of residential violence.
